#### **Preparatory Committee**

Third session

1st meeting

Opening of the third session

His Excellency Thani Thongphakdi (Thailand), Co-Chair of the Preparatory Committee for the Third United Nations World Conference on Disaster Risk Reduction, declared open the third session of the Preparatory Committee.

The Co-Chair made a statement.

Adoption of the agenda and other organization matters of the Preparatory Committee [item 1]

The Committee adopted the agenda for its third session, as contained in document A/CONF.224/PC(III)/1.

Election of officers

The Committee elected His Excellency Banak Joshua Dei Wal (South Sudan) as Vice-Chair of the Preparatory Committee for the Third United Nations World Conference on Disaster Risk Reduction.

The Committee designated Her Excellency Katerina Sequensova (Czech Republic) as Rapporteur of the Preparatory Committee for the Third United Nations World Conference on Disaster Risk Reduction.

The Committee was informed that His Excellency Takeshi Osuga (Japan) would serve as an ex-officio member of the Bureau of the Preparatory Committee for the Third United Nations World Conference on Disaster Risk Reduction.

Accreditation of non-governmental organizations and other major groups

The Preparatory Committee approved the list of non-governmental organizations and other major groups, as contained in document A/CONF.224/PC(III)/2, who would participate as Observers in the Third United Nations World Conference on Disaster Risk Reduction.

Participation of intergovernmental organizations

The Preparatory Committee approved the list of intergovernmental organizations as contained in document A/CONF.224/PC(III)/3 who would participate as Observers in the Third United Nations World Conference on Disaster Risk Reduction.

Draft post-2015 framework for disaster risk reduction [item 2]

The Preparatory Committee decided to recommend to the Conference that the negotiations on the draft post-2015 framework for disaster risk reduction be continued in the Main Committee.

The Preparatory Committee further agreed to the modalities for proceeding with informal discussion on the draft post-2015 framework for disaster risk reduction immediately following the adjournment of the first meeting of the Preparatory Committee.

Draft political declaration [item 3]

The Preparatory Committee decided to recommend to the Conference that the negotiations on the draft political declaration be continued in the Main Committee.

Other Matters [item 4]

The Preparatory Committee decided to revise the provisional agenda of the Conference, as contained in document A/CONF.224/1, by replacing "4. Adoption of the agenda and programme of work" with "4. Adoption of agenda and other organizational matters" (A/CONF.224/PC(III)/L.1).

The Preparatory Committee further decided to recommend to the Conference that, at the opening of the Conference, statements also be made by the Prime Minister of the host country, the incoming President of the twenty-first session of the Conference of the Parties to the United Nations Framework Convention on Climate Change, and the Mayor of Sendai City (A/CONF.224/PC(III)/L.1, as orally revised).

The Preparatory Committee also decided to recommend to the Conference that its first plenary meeting be held from 11:00 to 13:30, on 14 March 2015 (A/CONF/224/PC (III)/L.1).

2nd meeting

Adoption of the report of the Preparatory Committee on its third session [item 5]

The Rapporteur of the Preparatory Committee, Her Excellency Katerina Sequensova (Czech Republic), made a statement, in which she introduced the draft report of the third session of the Preparatory Committee, as contained in document A/CONF.224/PC (III)/L.2.

The Committee adopted the draft report of the third session of the Preparatory Committee, as contained in document A/CONF.224/PC(III)/L.2, and authorized the Rapporteur of the Preparatory Committee to finalize the report in light of the proceedings of the present meeting with a view to its submission to the Conference.

#### Circulation of written statements

All delegations, prior to delivery of the statement, are kindly requested to e-mail a copy of their statement to wcdrr2015@un.org, indicating in the subject line, "Statement and name of country or organization". Where possible, statements should be provided one day in advance of delivery or at least three hours before the delivery of the statement for onward transmission to interpreters and secretariat note-takers and for posting on the Conference website.

#### **Arrangements for bilateral meetings**

For bilateral meetings among States at the Head of State or Government or ministerial level, requests can be sent to <a href="wcdrr2015@un.org">wcdrr2015@un.org</a>. To prevent double booking, only the delegation initiating the bilateral meeting should submit the request. Reservations will be accepted for 20-minute durations. It is essential that all requests specify the date and time of each meeting, and include the name of the other delegation participating in the bilateral meeting and expected number of participants. Limited rooms, of varying sizes with a capacity to hold between eight, ten or twelve participants in total, will be available for bilateral meetings. Every effort will be made to keep consecutive appointments of the same delegation in the same room.

#### Live webcast coverage
